Membership Agreement and Service Contract

The applicant for service (whether one or more, hereinafter called the “Applicant”) hereby applies for membership in Magnolia Electric Power (hereinafter referred to as “MEP”) and agrees to purchase electricity energy from MEP upon the terms and conditions set forth below, and upon acceptance of this application by MEP shall be found and agrees as follows by receipt of service:

1. To pay each month, on or before such day of the month as may be designed by MEP from time to time, for the number of kilowatt hours consumed the immediate preceding month at rates fixed by MEP, or a minimum charge fixed by MEP, whichever is greater.
2. To cause property where electric service is received to be wired in accordance with standards and specifications in the latest revision of The National Electric Code:
3. To comply with and be bound by the Charter and Bylaws of MEP and such lawful rules and regulations as may, from time to time, be adopted by MEP.
4. To grant and convey to MEP all necessary easements and right-of-way on, over and across Applicants’ property for the location, construction, installation and maintenance of such transmission, distribution or service lines, or any combination thereof, as may be reasonably necessary to supply electric energy to such buildings or other points on said property as supplied with electric energy by MEP; To give and grant to MEP, its agents, servants and employees the right to enter upon Applicant’s property at any and all times for the purpose of construction, maintaining and operating MEP’s electric power system and further grant the right to cut, trim and remove trees and shrubbery on Applicant’s property to the extent deemed necessary by MEP for the purpose of constructing, maintaining and operating said electric power system;
5. That, if this application is by husband and wife, their membership, and all capital credits and other benefits of membership thereto related, shall be owned by them as joint tenants, with the right of survivorship, and not as tenants in common, and, subject to MEP approval, any transfer thereof or withdrawal or action related thereto may be made or taken by either the husband or the wife or the survivor of them;
6. That if Applicant is delinquent in the payment of any amount owed MEP, for electric service otherwise, at the time there is distributable to Applicant any capital credit or other benefit of membership, all or so much as may be deemed necessary by MEP may be applied toward satisfaction of such delinquency;
7. Assume liability and pay for (a) the account for which electric service is rendered by MEP, at the location for which application for service is made, (b) any delinquent account or amount owed by MEP where the member or applicant has resided at the location receiving service but only for such delinquency or account which occurred while the member or applicant was a resident, (c) all cost of collecting the amount owed under this agreement including court costs and reasonable attorney fees;
8. Upon acceptance of this Application by MEP and the receipt of electric service by the Applicant this instrument shall constitute the service contract between the Applicant and MEP and shall remain in force and effect until cancelled by either party. Cancellation may be effected only by 30 days written notice thereof given by either party to the other.
